1. CALL TO ORDER

Mr. Joshua Orozco called the meeting to order at 4:03 pm.

4. CHANGES TO THE AGENDA

5. APPROVE MINUTES

A. September 12, 2016

7. PRESENTATION BY TOM FIGART, CRRUA ATTORNEY ON THE JOINT POWERS AGREEMENT FOR A JOINT WATER AND WASTEWATER OPERATING AUTHORITY AND JOINT SUBDIVISION, ZONING, PLANNING, AND PLATTING AUTHORITY BETWEEN THE CITY OF SUNLAND PARK AND THE COUNTY OF DONA ANA, NEW MEXICO

Mr. Tom Figart, CRRUA Attorney presented the board members with the joint powers agreement for a joint water and wastewater operating authority and joint subdivision, zoning, planning, and platting authority between the City of Sunland Park and the County of Dona Ana, New Mexico.

8. BOARD COMMENTS

State Representative Bealquin Gomez stated that they need to work on spending capital outlay 2015 funds before January or before they get reverted back .

Councilor Francisco Jayme stated that there should be a safety water service for the resident amendment in the JPA that the JPA needs to give priorities to the health and safety of the water and wastewater services and that it needs to get amended or mission statement added to reflect that massage.

9. STAFF COMMENT

Mr. Brent Westmoreland, CRRUA Executive Director informed the board that the \$3.7 million dollar matching grant to an \$8.1 million dollar NADBANK grant to rebuild the North wastewater treatment plant was in danger to get revert back. The \$3.7 million was considered part of the capital outlay funding that would be reverted back to make up for the current fiscal year's deficit by the New Mexico House and Senate leaders. The federal grant was released from the reversion list, after a conversation with LFC Executive Director David Abbey, Capital Outlay Director, Linda Kehoe, and CRRUA, following a letter from EPA stating that CRRUA was in compliance. Now CRRUA needs to get the funds encumbered before the next legislative session. The rest of CRRUA's grant were intact.

Mr. Brent Westmoreland also informed the board members that well 4 will go out to bid in the next few months. Wells 19 and 8A bids are due November 1, 2016 this wells primarily serves Santa Teresa communities. Once the new arsenic plant gets on line the water could be pump to Sunland Park. Sunland Park residents are drinking treated water below the EPA arsenic levels. Once the new arsenic treatment plant gets on line the Santa Teresa residents will also be drinking treated water below the EPA arsenic levels. Well 14 will be going out to bid soon. Well 14 will be channel to Sunland Park, Santa Teresa and the industrial areas as necessary.

Mr. Westmoreland informed the board members that starting November they will be receiving quarterly financials.

Eric Lopez, Bridel Facility Operations presented to the board members with the September 2016 operations monthly reports of the CRRUA water and wastewater system.

10. PUBLIC COMMENTS: Limited to 3 minutes per person.

Ms. Isabel Santos, Resident expressed her disagreement on the new disconnections fees. Also expressed her concern on the water issues.

Ms. Jacqueline Derrick, Resident asked if they have any programs that help community with arsenic issues with water faucet filters.

Ms. Rita Trevino and Ms. Mary Gonzalez, Residents expressed her concern on the issues with the arsenic in the water system.

11. ADJOURNMENT

Chair Mr. Joshua Orozco moved to adjourn the Camino Real Regional Utility Authority meeting, seconded by all board members.

The meeting adjourned at 6:13 p.m. The motion carried.
